### Product:

"SUNGLAZE® Solid Polycarbonate Standing-Seam architectural sheets of 3mm thickness or above (hereinafter "the Product") are hereby warranted by Palram Americas, Inc. (hereinafter "the Manufacturer"), subject to any other terms contained herein.

### Scope of Warranty:

This Warranty applies only to the original property owner at the time the Product is installed (the "Owner"). In this Warranty, "Owner" shall also mean the occupant of a leased property who installs the Product or contracts to have it installed at such leased property, which it occupies at the time of installation.

Collectively, the term "Warranty" shall mean the following warranties:

#### A. Light transmission Warranty:

The Product shall not lose more than 6% of its light transmitting capacity from the original date purchased for a period of 10 years as a direct result of the effect of solar radiation as measured to the procedures in ASTM D1003-13 (hereinafter referred to as "Decrease"). Decrease is measured by comparing the Product's original light transmission capacity vs. a cleaned sample taken from the installation site.

#### B. Color Warranty:

The Product shall not display an increase in yellowness (as measured according to the procedures in ASTM D1925-77) (hereinafter a "Color Change") of more than 10 units delta in the case of transparent products or 15 units delta in the case of White Opal or Diffuser products (hereinafter, the "Permitted Color Change") for a period of 10 years from the Commencement Date (as defined below) as a direct and exclusive result of the impact of solar radiation. The baseline for determining Color Change shall be determined according to the Manufacturer's standard product literature at the time of the original sale.

#### C. Hail Warranty:

The Product shall not break due to excessive loss of impact strength as a direct and exclusive result of the impact of hail, measuring up to 1 inch in diameter, attaining a velocity of up to 20 m/s for a period of ten (10) years from the Commencement Date (hereinafter referred to as "Breakage").

Loss of impact strength will be determined by testing conducted by the Manufacturer according to ISO 6603/1-1985(E) and/or ASTM D-5628-95 method F, to be applied on a sample of the broken sheet provided by the Owner. This Hail Warranty only applies if the sample will be brittle broken during this test into separate pieces (shatter).

### D. Leakage Warranty

The Product shall not allow moisture, directly related to rain, snow or ice, to pass directly through from the top surface of the Product to the ground below the bottom surface of the Product by way of the standing seam joint system (hereinafter referred to as "Leakage" for a period of twenty five (25) years from the Commencement Date. Leakage will be inspected by the Manufacturer at the installation site. Damage by hail is the only type of impact covered by the Leakage Warranty and therefore no other type of impact damage will be covered by the Leakage Warranty.

### Commencement Date

The commencement date of this Warranty (the "Commencement Date") shall be the date the Product was purchased by the Owner.

### Conditional Limitations

This Warranty shall be valid only if:

- The Product is used for normal purposes as specified by the Manufacturer.
- The original proof of purchase is presented.
- The Product is stored, installed, handled, cleaned and maintained in accordance with the Manufacturer's written instructions which are available on-line at [www.palramamericas.com/Products/Corrugated-Sheets/SUNSKY/](http://www.palramamericas.com/Products/Corrugated-Sheets/SUNSKY/), and is used only in a customary fashion.

Except as described in the Hail Warranty, the Product is not warranted against any effects of natural disasters, and is not warranted to any extent against misuse, intentional damage, accidental damage or use for an inappropriate application.

This Warranty does not cover any costs and expenses of removal and installation of the Product or taxes or shipping cost or any other direct or indirect losses that may result from the Product failure.

### Claims and Notifications

Every Warranty claim must be submitted by the Owner in writing to the Manufacturer or original dealer promptly after occurrence of Decrease, Color Change or Breakage, enclosing the original sales receipt or other proof of purchase and this Warranty. Owner may make only one claim each under the Warranty against Decrease, Color Change, Breakage or Leakage for any particular installation over the lifetime of the Product. The Owner must (a) allow the Manufacturer an opportunity to inspect any or all of the sheets involved and the installation site itself while the sheets are still in their original position and have not been removed, moved or altered in any way, or (b) upon the Manufacturer's request, return a sample of the sheets to the Manufacturer for testing. The Manufacturer reserves the right to investigate independently the cause of any failure.

### Where to File Claims to Manufacturer

### Compensation

If a claim is covered under this Warranty, then the Manufacturer will provide the Owner with free replacement Product or, at the Manufacturer's discretion, refund all or part of the original purchase price paid by Owner, in accordance with the Refund Tables listed below. A replacement Product is warranted only for the balance of the time remaining in the Warranty on the original Product.

### Refund Tables

#### Loss of Light Transmission and/or Color Change

If, over a specific period of time, the Product either (a) loses a greater percentage of its light transmitting capacity and/or (b) has a greater Color Change than the allowed during that time under the aforementioned Warranties and the Manufacturer elects to make a refund rather than supply replacement Product, the applicable refund percentages are as follows, based on the time elapsed from the Commencement Date to the time the loss is reported to the Manufacturer:

Time Elapsed After Commencement Date	Owner will be refunded this percentage of original purchase cost
End of 5th year	100%
End of 6th year	50%
End of 7th year	40%
End of 8th year	30%
End of 9th year	20%
End of 10th year	10%

### Hail

If the Product fails to meet the Hail Warranty, and the Manufacturer elects to make a refund rather than supply replacement Product, the applicable refund percentages are as follows, based on the time elapsed from the Commencement Date to the time the Breakage is reported to the Manufacturer:

Time Elapsed After Commencement Date	Owner will be refunded this percentage of original purchase cost
To end of 3rd year	100%
End of 4th year	85%
End of 5th year	70%
End of 6th year	55%
End of 7th year	40%
End of 8th year	30%
End of 9th year	20%
End of 10th year	5%
After 10th year	0%

### Leakage

If the Product fails to meet the Leakage Warranty, and the Manufacturer elects to make a refund rather than supply replacement Product, the applicable refund percentages are as follows, based on the time elapsed from the Commencement Date to the time the Leakage is reported to the Manufacturer:

To end of 3rd year	100%
End of 4th year	95%
End of 5th year	90%
End of 6th year	85%
End of 7th year	80%
End of 8th year	75%
End of 9th year	70%
End of 10th year	65%
End of 11th year	60%
End of 12th year	55%
End of 13th year	50%
End of 14th year	45%
End of 15th year	40%
End of 16th year	35%
End of 17th year	30%
End of 18th year	25%
End of 19th year	20%
End of 20th year	15%
After 20 years	Subtract 1% every year of service after 20 years; minimum of 10% is reached after 25 years

### Example:

If by the end of the sixth year the Product has lost 12% of its original light transmission capacity, and that loss is more than the permitted Decrease such that the Product is not in compliance with the Light Transmission Warranty, then the Manufacturer would elect either to provide 100% replacement Product or refund 50% of the original cost of the Product.

### Jurisdiction

This Warranty is governed by and shall be construed according to the laws of the Commonwealth of Pennsylvania, USA. Any claim or dispute related to the product and/or this Warranty shall be exclusively brought before the appropriate court in the Commonwealth of Pennsylvania, USA, which shall have the exclusive jurisdiction in any such claim or dispute.
